

Leave a Legacy through Impact Ministries Canada

Adding Impact Ministries Canada to your will is a meaningful way to leave a legacy and support a cause you care about. It can also continue the sponsorship of your child or class when you're no longer able to.

Your lawyer or notary can add wording to your will, specifying:

1. Full Legal Name of Charity: **Impact Ministries Canada**
2. Charitable Registration Number: **89107 0625 RR0002**
3. The amount you would like to donate:
 - **A specific amount**
 - **A percentage of your estate, or**
 - **The remainder of your estate** after other gifts
4. The Purpose of Your Gift
 - Where Most Needed (*"for such purposes and designs as deemed appropriate by Impact Ministries Canada"*)
 - The Jubilation Fund (*"for the General Capital Restricted Fund"*)
 - Continuing Your Sponsorship (*"to continue the sponsorship of any sponsor child or class"*)

Sample Bequest Wordings:

For a general gift to be used **where most needed**:

*To pay Impact Ministries Canada (Canadian charitable registration number BN # 89107 0625 RR0002) _____% of the residue of my estate [OR the sum of \$_____].
This gift is to be used for such purposes and designs as deemed appropriate by Impact Ministries Canada.*

For a gift to the **Jubilation Fund**:

*To pay Impact Ministries Canada (Canadian charitable registration number BN # 89107 0625 RR0002) _____% of the residue of my estate [OR the sum of \$_____].
This gift is to be used for the General Capital Restricted Fund. If through the passage of time, this fund is no longer in place, the gift may be used for such purposes and designs as deemed appropriate by Impact Ministries Canada.*

For a gift **continuing your sponsorship**:

To pay Impact Ministries Canada (Canadian charitable registration number BN # 89107 0625 RR0002) _____% of the residue of my estate [OR the sum of \$_____].

This gift is to be used to continue the sponsorship of any sponsor child or class that I was sponsoring at the time of my death, for as long as Impact Ministries Canada, in its discretion, considers it advisable.

If I am not sponsoring a child or class at my death, or when all sponsorships are complete, this gift may be used for such purposes and designs as deemed appropriate by Impact Ministries Canada.
